**NOTICE TO MARINERS No 53 OF 2009**

**Special Mark Buoys delineating the 200-metre Restriction Zones**

The Malta Maritime Authority notifies that in terms of Section 7 of the MMA Act (Cap 352) and the Small Ships Regulations, Several buoys have been placed around the Maltese Islands to delineate the 200-metre restriction zones. The buoys are seasonal and may be in place between June and October.

**Reference is made to BA Chart 2537, 211A**

5 yellow cylindrical buoys, which are 1.5 metres in diameter, flashing 1 every 4 seconds and having 2 Nautical Miles range, have been placed in the following positions:

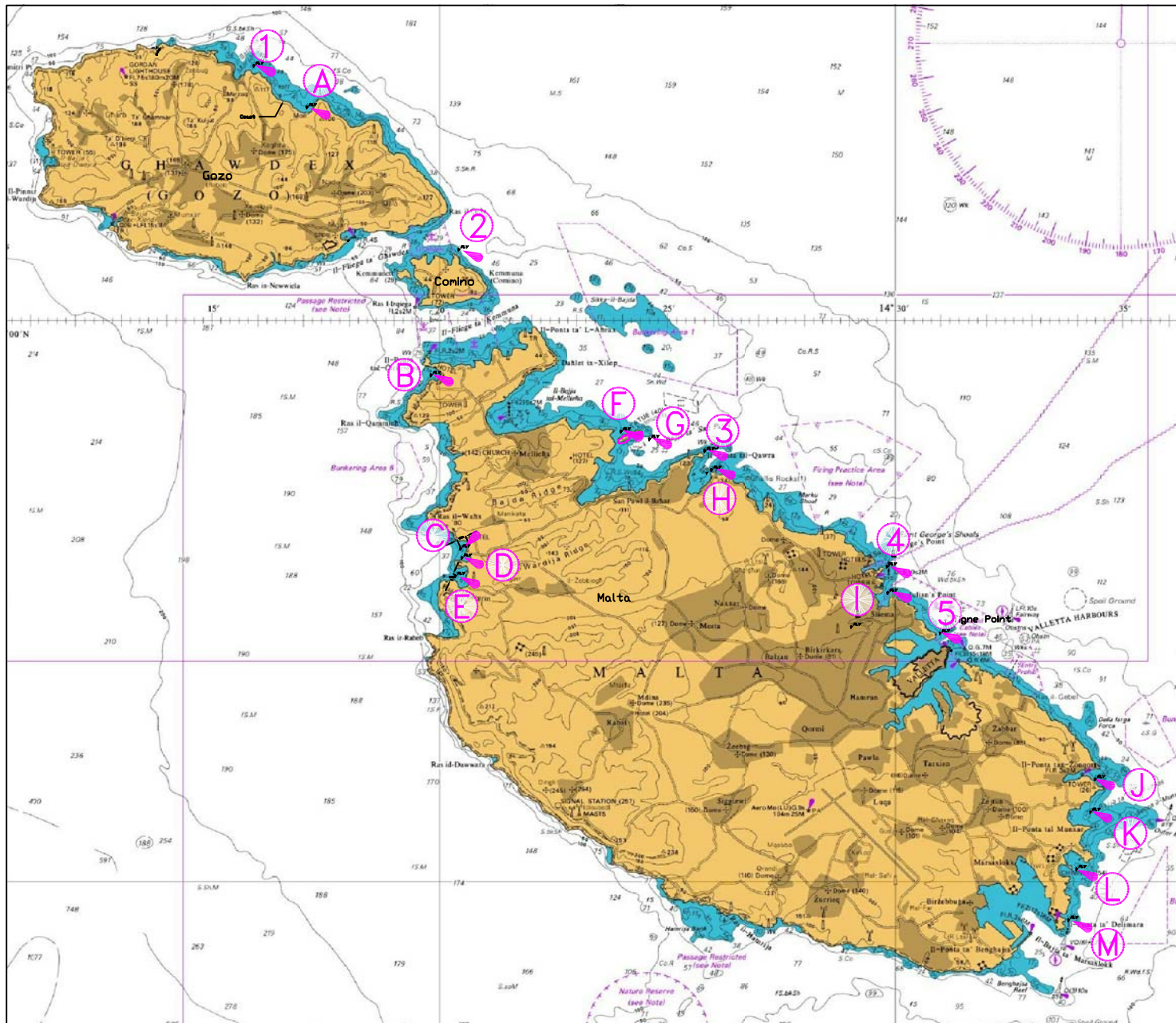
